

Student Supports



Educational Assistant support for Special Needs Students

Has declined by nearly 20 in the past three years. Additional resources that support educators and schools to provide inclusive learning have also been reduced.

Student Mental Health



705 School Social Workers Referrals

2018/19 School Social Workers in Wolf Creek Public School have made:

- · 307 referrals to Alberta Health Services
- 333 referrals to Local Agencies
- · 65 referrals to Children's Services

Lack of Mental Health Access in rural Alberta often sees cases going to schools for support.

A reduction of Full-Time Social Workers in schools over the past four years.

Rural Funding Equity



A rural school could receive \$40,000 less per class (with an avg. class size of 16 students), compared to a class size with 22 students.



In all areas, funding does not address changing populations in rural communities.



All schools require administrators, support staff and central office support whether there are 500 or 50 students. Funding does not reflect these needs in rural schools

What do I do?

What do I write about?


- Keep it factual and short.
